Andy Koetz reported that his father, Bob Koetz, has had an infection and gave an up-date on his status.

Treasurer Joe Fishbein gave his report, which covered July and August 2006. Cash in checking account, as of July 1, 2006, was \$5,083. Income during the period was \$136 in dues and donations and \$2 in checking account interest, for total income of \$138. Expenses were \$88 in dues payments to NRHS national office and \$218 in newsletter expenses, for total expenses of \$306. Cash in checking account, as of August 31, 2006, was \$4,915, of which

\$3,175 was in the General Fund and \$1,740 was in the GTW 8327 Restoration Fund. Funds in CDs and investments is \$31,000. Current chapter membership status is 93 members,
