April 26, 27 NRHS Board Meeting Report -by John Goodman (edited)

Greg Molloy on Sunday took quite a bit of time to lecture those assembled about how dues renewals for 2014 are down 5% according to the latest On Board report. Last year we sat at 86% verses this year at 81%.

Greg mentioned that certain chapters are changing their own by-laws to allow for people to be chapter members only and not join the National at all. Greg said (and he is correct) that the National by-laws specify that anyone joining a chapter MUST also belong to the National group, This is not being done by several chapters, and these members are not legal. Greg (after much discussion) told his Relationship Committee to have an answer by the summer convention to this problem. He mentioned that several chapters (not us) have refused to submit any dues money to the national office. Greg mentioned that one solution would be to "pull" the charter from that chapter. Another answer might be to charge such chapters a franchise fee to belong to the NRHS, if they refused to follow the by-laws of the National organization. A question was asked from the floor to Greg as to what actually does the National office provide to the chapters? He did not answer this question. Several of those attending this Sunday meeting got up and explained to Greg that in each case of non-renewal, those folks told the chapter that the dues increase and new way of paying for dues in 2015, what with the two payments necessary, one to the National with a credit card of paypal, and the second to the local chapter, was inconvenient. Another criticism mentioned was the last few bulletins content was very poor. Jeff Smith answered by saying that our publication (unlike Trains, Railpace, etc) is the only RR publication that can devote a full issue to one subject. The biggest problem now facing the NRHS (besides the above) is with Fernley & Fernley. The accounting department seems to have problems in documenting the NRHS financial records. We are unable to fill the necessary IRS form 990, due 6/15/14 due to these accounting problems with Fernley & Fernley staff. Greg reported that losses to the NRHS in 2013 were larger than expected. Our auditors (EGA) are unable to make a 2013 audit due to the accounting problems with the data that Fernley & Fernley is trying to provide. Greg said that quote: "I just don't believe the data given to us from Fernley & Fernley". The Fernley & Fernley contract is due to be renewed by 4/30/14, but due to the many problems with the audit, the NRHS is requesting a 60 day extension until 6/30/14, which the management of Fernley & Fernley has agreed to allow. Because of the above problems. NRHS is unable to produce a 2014 budget at this time. A motion was approved to continue with a 80% budget from the 2013 budget. Because of the above...NRHS has hired an audit oversight group under James Little to review the data that EGA was not able to, and make some sense out of it. The group is called the Part Time Controller Group. The NRHS Privacy Policy (Jeff Smith and John F.) is not yet ready and will be delayed until the summer convention meeting.

I was disturbed to read a report about the NRHS April Board of Directors meeting on page 5 of the May 2014 Northstar News. This report contains numerous inaccurate statements, misleading statements taken out of context, and several instances of the author's personal opinion being presented as fact.

What is most disturbing is that some of the many erroneous statements are structured to imply that they are either things I said or were otherwise reported to the Board of Directors by NRHS management. If the Northstar Chapter wishes to publish inaccurate information, that is one thing. But to also imply that this misinformation came from me personally or other members of NRHS management is totally unacceptable.

Let me address only a few of the serious errors in this report that are attributed to me:

"We were unable to fill (sic.) the necessary IRS form 990, due 6/15/14 due to these accounting problems with Fernley & Fernley staff."

What I actually reported to the Board was that the normal deadline for filing the 990 was May 15. For a non-profit organization of our size and complexity, this has always a challenging schedule, and we had filed for an extension to August 15, as we do almost every year. Such filing extensions are very common and approval is almost automatic. We do not expect to file the 990 by May 15, but we are on track to file it in June, as we do almost every year.

What I actually reported was that because recent draft financial reports from Fernley & Fernley contained information we recognized to be inaccurate, NRHS has not released unaudited preliminary 12/31/2013

financial statements, and we will not do so until we receive the audited financial statements from Padden Guerrini & Associates, our regular audit firm. The audit is proceeding on the normal schedule and draft audited financial reports are expected in early May.

What I actually reported was that NRHS has engaged Your Part-Time Controller, a Philadelphia-based firm specializing in accounting services to non-profit organizations, to provide accounting oversight and reporting services previously contracted to Fernley & Fernley. The accounting management functions were a small part of Fernley's scope of work for NRHS. The quality of that accounting work had deteriorated recently following personnel changes and NRHS determined it was in the best interest of the Society to change suppliers for that specific part of the work. In a separate action at a different time, the Board of Directors ratified an earlier Executive Committee action to grant read-only access to NRHS bank records to James Little, an employee of YPTC assigned to the NRHS account.

In short, reality is somewhat less exciting than the recent reports in the Northstar News. NRHS remains concerned about the recent quality problems with the accounting management at Fernley & Fernley. These problems have consumed far more time and energy than they should have, and they have delayed financial reports and budgeting work that should have been done already. NRHS management is aware of the issues and is working actively to resolve the problems in the best interests of the Society.

However, these efforts are not helped by the publication of false and inaccurate statements in chapter newsletters, especially when done with the implication that those statements came from NRHS management. Such statements have a way of of getting picked up and passed on in other newsletters until they acquire a life of their own. What is more alarming is a statement elsewhere in the same issue that the Northstar News will now suspend publication until the fall, so we have no opportunity to refute or correct these statements.

For that reason, NRHS must request that Northstar Chapter publish either a retraction of this article or this refutation immediately (not in the fall) to the full readership of the Northstar News. Failing that, NRHS requests the full distribution list (electronic and paper) for the Northstar News so that the Society can issue its own response.

If you need additional information regarding these or other errors in the article, I will be happy to discuss them with you. In the meantime, however, we trust this matter will receive your immediate attention. Greg Molloy President, NRHS
